

## Agon Rec: Pickup Sports Privacy Policy

Revised as of August 26, 2025

Agon Rec (a mobile application) and [www.AgonRec.com](http://www.AgonRec.com) (the "Website") is operated by Agon Inc. (sometimes referred to as "we," "our", or "Agon" hereinafter). Agon has created this privacy policy to demonstrate our firm commitment to the privacy of our Members, Recreational Partners, and users. Agon is committed to respecting your privacy and recognizing your need for appropriate protection and management of personally identifiable information you share with us (the phrases "Personally Identifiable Information" and "Personal Information" mean any information by which you, individually, can be identified, such as your name, address, telephone number, etc.). The purpose of this privacy policy is to inform you when you visit our Website how we use such information.

This privacy policy also governs the collection, use, transfer, and processing of your Personal Information. By using this Website, you consent to our privacy policy set out below. All terms not defined in this document have the meaning ascribed to in our terms and conditions located at <https://www.agonrec.com/terms-of-service>.

**Children's Online Privacy Policy and COPPA.** Agon is concerned about children's privacy. This Website provides Services for all Members and users, including Members and users under the age of 18. While we encourage Members and users 13 years of age or older to participate appropriately in our Website and its Services, their privacy is important to us.

**You must be at least 13 years of age and have parent or legal guardian consent and supervision to use this Website and participate in its Services. By using this Website, you are agreeing to the terms and conditions and privacy policy. Children (under the age of 13) are not**

**eligible to use the Website, and we ask that you do not submit any Personal Information to us.** If you are under the age of 18, you may only use this Website in conjunction with, and under the supervision of, your parents or guardians. Providing false, or inaccurate information is a violation and will be grounds for immediate termination of access to the Services.

**General.** In general, you may visit the Website without telling us who you are or revealing any of your Personal Information. Even if you do not submit content to us, we still collect all information that you submit to us, including any Personal Information you submit, via our Contact Us page. Whether or not you choose to provide Personal Information is entirely up to you. We may also track the domain address from which you visit the Website through cookies (see "Cookies" Section below). The manner in which we will collect and use your information is set forth below.

**Information We Collect.** The information we gather enables us to personalize, improve and continue to operate the Service. This includes but is not limited to, personalized Event recommendations, performance tracking, and sending you notifications such as email and other marketing communications. In connection with certain aspects of the Service, we may request, collect and/or display some of your Personal Information. We collect the following types of information from our Members, users, and/or Recreational Partner.

**Account Information.** When you create a Member Account or Partner Account, you will provide information that could be Personal Information, such as your name, address, and email address. You acknowledge that this information may be personal to you, and by creating a Member Account or Partner Account on the Service and providing Personal Information to us, you allow others, including us, to identify you and therefore may not be anonymous. We may use your contact information to send you information about our Services. You may unsubscribe from these messages through your Account settings, although we, regardless, reserve the right to

contact you when we believe it is necessary, such as for Account recovery purposes.

**Purchases.** If you choose to make a purchase through our Services, you allow us to collect Personal Information such as your name, address, email address, and phone number. We will use this information in accordance with this privacy policy.

**Financial Information.** We may collect financial information, such as your payment method (valid credit card number, type, expiration date or other financial information); that information is collected and stored by our third-party payment processing company (the "Payment Processor") and use and storage of that information is governed by the Payment Processor's applicable terms of service and privacy policy. We may from time-to-time request and receive some of your financial information from our Payment Processor for the purposes of completing transactions you have initiated through the Services, protecting against or identify possible fraudulent transactions, processing refunds, and otherwise as needed to manage our business.

**IP Address Information and Other Information Collected Automatically.** We automatically receive and record information from your web browser when you interact with the Service, including your IP address and cookie information. This information is used for fighting spam/malware and also to facilitate collection of data concerning your interaction with the Service (e.g., what links you have clicked on).

Generally, the Service automatically collects usage information, such as which parts of the Website you use and the number and frequency of users who visit the Website. We may use this data in a manner that would identify you personally. This type of data enables us, and third parties authorized by us to figure out how often individuals use parts of the Service so that we can analyze and improve them.

**Email Communications.** We may receive a confirmation when you open an email from us. We use this confirmation to improve our Service.

**Aggregate Information.** We collect statistical information about how both Members, Recreational Partners, and users collectively, use the Service ("Aggregate Information"). Some of this information is derived from Personal Information. While Aggregate Information is not Personal Information, it may be tied back to you, or your web browser.

Agon adheres to the U.S. safe harbor policy privacy principles of notice, choice, onward transfer, security, data integrity, access, and enforcement. **Cookies and Unique Identifiers.** The Website may use cookie technology to improve the quality of your experience. A cookie is a small file that contains information sent by a website that is saved on your hard disk by your computer's browser. Cookies store information that a website may need in order to personalize your experience and gather website statistical data. Any time you visit the Website to browse, or to read or download information, cookies may collect and store the name of the domain and host from which you access the Internet (for example, msn.com, aol.com, etc.); the Internet protocol (IP) address of the computer you are using; the browser software you use and your operating system; the date and time you access the Website; and the Internet address of the website from which you linked directly to the Website. We may use this information to measure the number of Members, Recreational Partners, and users who visit certain areas of the Website, and to help us make the Website more useful and interesting to our Members and users. Generally, we may use cookies to gather statistical information about Website such as Website visiting patterns to help target advertisements based on Member and user interests. If we use information from cookies, it will only be in the aggregate to analyze trends and statistics.

Some consumers may not know that cookies are being placed on their computers when they visit websites. If you want to know when this happens, or to prevent it from happening, you can set your browser to advise you when a website attempts to place a cookie on your computer.

In addition, we may use unique identifiers, including but not limited to, a string of characters specific to your mobile device, GPS location, camera and/or photos access, and information about the network your mobile device is connected to, and your IP address. Any time you access the App we collect and receive information about the different devices you use and how you use them. We may use this information to measure the frequency of users accessing specific features and/or functions of the App, to help us make the app more useful for users and Recreational Partners, fraud prevention, as well as security and compliance purposes.

**Information We Share.** The Service is designed to help you share information with others. As a result, some of the information generated through the Service is shared publicly or with third parties.

**Public Information about Your Activity on the Service.** Some of your activity on and through the Service is public by default. This may include, but is not limited to, Content you have posted publicly on the Website or otherwise through the Service.

Members and/or Recreational Partners may have some of this information associated with their Account. In addition, information concerning your use of the Service (such as what pages they have visited) may be tracked anonymously through the use of cookies and stored by us.

Please also remember that if you choose to provide Personal Information using certain public features of the Service, then that information is governed by the privacy settings of those particular features and may be publicly available. Individuals reading such information may use or disclose

it to other individuals or entities without our control and without your knowledge, and search engines may index that information. We, therefore, urge you to think carefully about including any specific information you may deem private in content that you create or information that you submit through the Service.

**IP Address Information.** While we collect and store IP address information, that information is not made public. We do at times, however, share this information with our partners, service providers and other persons with whom we conduct business, and as otherwise specified in this privacy policy.

**Information You Elect to Share.** You may access other Third-Party Services (as defined below) through the Service, for example by clicking on links to those Third-Party Services from within the Website. We are not responsible for the privacy policies and/or practices of these Third-Party Services, and you are responsible for reading and understanding those Third-Party Services' privacy policies. This privacy policy only governs information collected on the Service.

**Aggregate Information.** We share Aggregate Information with our partners, service providers and other persons with whom we conduct business. We share this type of statistical data so that our partners can understand how and how often people use our Service and their services, which facilitates improving both their services and how our Service interfaces with them. In addition, these third parties may share with us non-private, aggregated or otherwise non-Personal Information about you that they have independently developed or acquired.

**Email Communications with Us.** As part of the Service, you may occasionally receive email and other communications from us or our partners, such as communications relating to your registered Events, Credits, Agon promotions, or in response to a Contact Us submission.

**Information Shared with Our Agents.** We may employ and contract with people and other entities that perform certain tasks on our behalf and who are under our control (our “Agents”). We may need to share Personal Information with our Agents in order to provide products or the Service to you. Unless we tell you differently, our Agents do not have any right to use Personal Information or other information we share with them beyond what is necessary to assist us. You hereby consent to our sharing of Personal Information with our Agents.

**Information Disclosed Pursuant to Business Transfers.** In some cases, we may choose to buy or sell assets. In these types of transactions, Personal Information is typically one of the transferred business assets. Moreover, if our assets, or substantially all of our assets, were acquired, or if we go out of business or enter bankruptcy, Personal Information would be one of the assets that is transferred or acquired by a third-party. You acknowledge that such transfers may occur, and that any acquirer of us or our assets may continue to use your Personal Information as set forth in this policy.

**Information Disclosed for Our Protection and the Protection of Others.** We also reserve the right to access, read, preserve, and disclose any information as we reasonably believe is necessary to (i) satisfy any applicable law, regulation, legal process or governmental request, (ii) enforce this privacy policy and our terms and conditions, including investigation of potential violations hereof, (iii) detect, prevent, or otherwise address fraud, security or technical issues, (iv) respond to support requests, or (v) protect our rights, property or safety, and the public. This includes exchanging information with other companies and organizations for fraud protection and spam/malware prevention.

**Information We Share with Your Consent.** Except as set forth above, you will be notified when your Personal Information may be shared with third parties and will be able to prevent the sharing of this information.

**California Privacy Rights.** Under California Civil Code sections 1798.83-1798.84, California residents are entitled to ask us for a notice identifying the categories of personal customer information which we share with our affiliates and/ or third parties for marketing purposes and providing contact information for such affiliates and/or third parties. **GPDR Our Data Protection Officer.** Our Data Protection Officer is responsible for overseeing what we do with your information and monitoring our compliance with data protection laws. **Information Retention.** Your Personal Information will be retained by us for as long as we operate the Website, unless you have requested that your information be removed as set forth herein. When those purposes come to an end, we shall securely delete the personal data unless the retention of the personal data is required for archiving purposes in accordance with Article 89 (1) of the GDPR or other applicable provisions under the Data Protection legislation.

**Your Rights .**In relation to the information which we hold about you, you are entitled to:

- see a copy of the information;
- ask us to rectify the information where it is inaccurate or is incomplete. If we agree the information is inaccurate or incomplete



and make the rectification, we will inform any recipients of the information of the change, where possible;

- ask us to erase the information, but we will not be able to comply where we hold your information to fulfill our statutory regulatory and representative obligations;
- ask us to restrict what we do with your information, but there are a number of exemptions relating to this right;
- object to our use of your information and ask us to stop that use, in certain circumstances; and
- instruct us to provide you with the information we hold about you in a structured and commonly used format or transmit that information directly to another organization.

Our obligations to comply with the above rights are subject to certain exemptions.

Where we are using some of your information because you have provided your consent to that use, you are entitled to withdraw your consent at any time.
